- a) Update on Water Year 2025 Manager explained that the 2025 season looks good. We have 7,200 acres of rice applied for right now and 100 acres of general crops. We are working through meter reading issues at the pump station along with power outage notification issues. The field staff should now be receiving any outage notifications. The Manager also reported that since Mike Niehues is still out on leave, we will be outsourcing our chemical treatments this year. The Manager rode around with both water operators to see how things were going. They both seemed to be doing well. The board discussed and agreed to get another side by side and Trailer, if needed, so that it is easier for both operators to use at the same time. The Manager will look into getting another one. The board also discussed the ongoing drain cleaning issues and the fact that it is the landowner's responsibility to clean the area that goes through their property. We will continue to discuss solutions and have a landowner's meeting at the beginning of next year to discuss it further with landowners.
