Dear Landowners and Growers,

The District has been notified by the Bureau of Reclamation that 2024 has been determined to be a Shasta non-critical year. This year type gives the District a 100% water supply for this season. It was decided by the Board of Directors to set this year's rice water rate at \$160 per acre. Water applications are due by April 19th and water payments will be due in four installments, the first upon return of the completed water application, and then each of the three following months you will be billed one quarter of the price.

We continue to install water measuring devices in your fields and will be beginning to measure water usage, throughout the district this season. Your water usage will eventually be measured in each field and entered daily in a district database for future reference. These records will be available when requested so that you may see how much water your field uses.

As in prior years, during the spray season, you may drain your fields one time to spray. If you must drain a field more than one time, each additional refill will be billed another \$10 per acre charge. Please remember that if you drain your field while other growers are either still receiving an initial flood or are already receiving a reflood, there may be a short waiting period before additional water is available to meet your needs.

In a continued effort to enhance communication between the District and it's growers, we are happy to announce the District is implementing a new voicemail/text/email alert system to provide you with important, real time information throughout the season. This new feature will NOT take the place of written correspondence such as billing or applications; it is simply meant to enhance District communications. The District sent out a test notification last week. If you did not receive a text, phone call or email, please call the office to ensure we have correct contact information on file.

Your water application has been included for your convenience. Please return your completed application with your first payment to the office. Also please fill in field acreages, turnout numbers and the crop you will be planting for each field that you will be farming this year. No water will be delivered until your application and first payment are received by the office. If you have any questions, please call the office at (530) 934-4801.
